RELEASE AND INDEMNITY AGREEMENT

THIS RELEASE AND INDEMNITY AGREEMENT made this ____ day of _____, 2012, by and between _____, and _____, natural parents, legal guardians or next friends of _____, a minor, and their respective heirs, personal representatives and _____ assigns, _____ with _____ residence _____ address _____ at _____, herein collectively called "RELEASOR", and Amridge University, Inc., an Alabama not for profit corporation, and its officers, trustees, employees, agents, affiliates, successors and assigns and Roger Shepherd, an individual, and his heirs, personal representatives and assigns, herein collectively called "RELEASEE", and is a release whereby Releasor extinguishes all of Releasor's rights and claims against Releasee as herein enumerated.

NOW THEREFORE, in consideration of the agreement of Releasee to allow _____, a minor (the "Minor") to attend a Future Preacher's Training Camp on the dates of July ____, through July ____, 2012 (the "Camp") on Releasee's campus in Montgomery, Alabama, and various other locations for a substantially reduced fee, and the instruction and training to be provided, and for other good and valuable consideration to Releasor, the receipt and sufficient of which are hereby specifically acknowledged, Releasor agrees as follows:

1. Releasor agrees to indemnify, defend and hold harmless Releasee and to specifically assume all responsibility and liability for any damage to property, injury (including death) and the release of all rights, claims, actions, causes of action, expenses and damages whatsoever arising from, growing out of, or in any manner or degree directly or indirectly caused by, attributable to, or resulting from the attendance by the Minor at the Camp.

2. This Release is intended by the parties to release all claims for injuries, damages or losses to Releasor or Releasor's person and property, whether known, unknown, foreseen, unforeseen, patent or latent, which Releasor may at any time have against Releasee. Releasor understands and acknowledges the significances and consequences of such specific intention to release all claims by Releasor and specifically on behalf of the Minor, and hereby assumes full responsibility for any injuries, damages or losses that Releasor and/or the Minor may incur from the above-mentioned occurrence.

3. Releasor further represents that Releasor has not assigned, conveyed, pledged or otherwise transferred to any person or entity any claim, asserted or unasserted, and will not assign, convey, pledge or otherwise transfer to any person or entity any claim, asserted or unasserted, that Releasor has and/or claims to have against Releasee arising from the matters released hereunder.

4. Releasor specifically waives the right to sue Releasee arising out of any matter released hereunder. In the event Releasor or any third party asserts any claim for damages, injuries (including death), or losses, Releasor shall be solely responsible for all attorney fees, costs and expenses incurred by Releasee and any verdict in connection therewith.

5. This Release is freely and voluntarily executed by Releasor on behalf of the Minor,

after having been apprised of all relevant information and data furnished by Releasor's attorney, and after having Releasor's attorney explain the terms used herein and the consequences thereof or, with knowledge that Releasor has the right to consult with an attorney, Releasor has elected not to do so. Releasor in executing this Release does not rely on any inducements, promises, or representations made by Releasee. Releasor agrees to cooperate fully, to execute any supplemental documents required by Releasee and to take all additional action that may be necessary or required to give full force and effect to the terms and intent of this Release which are not consistent with its terms.

6. This Release contains the entire understanding between the parties hereto concerning the subject matter hereof and entirely supersedes and replaces all prior and contemporaneous agreements and representations, written and oral. There are no representations, statements, agreements, restrictions, promises, inducements, warranties, covenants, arrangements or understandings, oral or written, between or among the parties hereto, relating to the subject matter of this Release, which are not fully expressed herein and no party shall be bound thereby. This Release may be amended only by written instrument duly executed by the parties, and no other act, document, usage or custom will be deemed to modify or amend this Release in any way.

7. If there is any legal action or proceeding between the parties hereto arising from or based upon this Release, the unsuccessful party to such action or proceeding shall pay to the prevailing party all litigation costs and expenses, including reasonable attorneys' fees, incurred by such prevailing party in such action or proceeding and in any appeal in connection therewith, and if such prevailing party recovers a judgment in any such action, proceeding or appeal, such costs, expenses and attorneys' fees shall be included in as part of such judgment.
