- 📌 If you have previously used your Education Benefits you will need to complete a VA form 22-1995 or VA Form 22-5495 and submit to the VA and send a copy to the Financial Aid Office.
- 📌 If you have a Certificate of Eligibility, please send the Financial Aid Office a copy.
- 📌 Chapter 30, Chapter 1606, and Chapter 1607 must certify their attendance monthly with the VA.
- 📌 Chapter 31 must submit a VA Form 28-1905 to the FA Office.
- 📌 Chapter 30, 1606, 1607, or 35 will receive payment directly from the VA; therefore, the student is responsible for payment to Amridge University prior to the beginning of the semester.
- 📌 Indicate on your registration each semester that you plan to use your VA benefits for the semester.
- 📌 Do not register for any course(s) for which credit may be awarded from any other source.
- 📌 You can contact the VA at 1-888-GIBILL1 or [www.va.gov](http://www.va.gov) - Forms can be completed at [www.va.gov](http://www.va.gov) under Quick List Veterans On-line Application (VONAPP).
- 📌 If the VA does not cover the total balance of tuition and fees, the veteran is responsible for paying the balance due.
