This is a voluntary agreement among member states and U.S. territories that establishes comparable national standards for the offering of postsecondary distance-education courses and programs. It is intended to make it easier for students to take online courses offered by postsecondary institutions based in another state. As a participating member, Amridge University is held to a standard of providing quality distance education.
